Our aim is to serve the role of producer for the implementation of RIKEN's research results to benefit society.

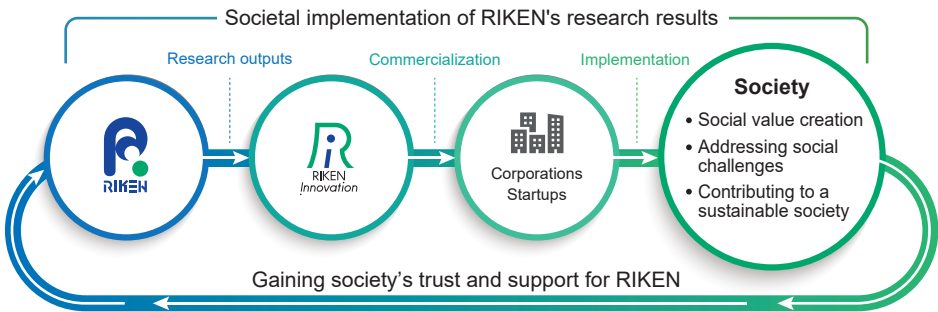

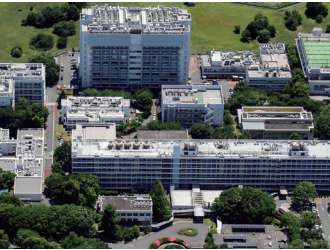
